



## CONTEST RULES

### 'Reveal the uniqueness of PBU projects'

#### Photo Contest

#### § 1

##### General rules

1. The contest is organized by the Center of European Projects - Joint Technical Secretariat of the Cross-Border Cooperation Programme Poland-Belarus-Ukraine 2014-2020 (hereinafter named the PBU Programme).
2. The aim of the Contest is to promote the richness and diversity of the PBU Programme area and the results of the projects implemented on the borderland of Poland, Belarus and Ukraine. The winning photos will be promoted in Poland, Belarus and Ukraine, among general public, institutions involved in the Programme implementation and among European institutions cooperating with the Programme.
3. The condition for taking part in the Contest is sending correctly filled application e-form, in accordance with these Rules.

#### § 2

##### Participation

1. The Contest is open to everyone, photographers and photo amateurs, regardless of age or place of residence.
2. A participant of the Contest can only be a person who is the author of a photo. One participant can submit up to five photos.
3. The photos should **PRESENT THE RESULTS OF THE PROJECTS** (what was done, the impact, how they affect people's life, how they changed the borderland) or **STILL ONGOING PROJECTS** (any kind of activities carried out under that projects). Beneath few examples:
  - actual carried activities;
  - built amphitheatres, restored historical buildings;
  - objects of small architecture – resting spots, observation tours, but also a view from an observation tower;
  - educational walking path, bike or kayak trails;
  - area where nature protection activities took or will take place – winery, natural national parks;or should **PRESENT THE ACTIVITIES ORGANIZED WITHIN THE PROJECTS**. Beneath few examples:
  - festivals, cultural events,
  - kayaking excursions,
  - workshops, etc.Photos should present **projects implemented within the Programme Poland-Belarus-Ukraine**. The list of Projects is available on the [Programme website](#) and the exact location on the map ([HERE](#)).
4. The submitted photos must meet the following criteria:
  - a) the attractiveness of the photo (promotional potential, innovative approach, original idea);
  - b) respond to the given task;
  - c) present the good technical quality of the photo:



- the photo should be clear, sharp without blurring
- type: jpg, tiff
- high-resolution: at least 96 dpi
- size: at least 1 MB

5. The condition of participation in the Contest is to send a correctly completed application form in accordance with § 2, along with the necessary consents. In the case of minors, consents must be approved by a legal guardian.
6. The application should be sent via the online form: [HERE](#) by **19<sup>th</sup> September 2021 (midnight CET)**. The date of receipt of the application form is decisive.
7. If it will not be possible to send the photos via the online form please contact the Organizer (mail: [monika.kozłowska@pbu2020.eu](mailto:monika.kozłowska@pbu2020.eu))
8. The submitted photos may not violate the law, including the rights of third parties, religious feelings, principles of social coexistence and, in relation to the Polish citizens, the GDPR - the General Data Protection Regulation of 27<sup>th</sup> April 2016, EU Journal of Laws L 119 of 4<sup>th</sup> May 2016 and the Act of 4<sup>th</sup> February 1994 on the copyright law and related rights (consolidated text, Journal of Laws of 2018, item 1191, as amended). The Participant is responsible for their non-compliance, and the Organizer reserves the right to exclude such works from the Contest.

### **§ 3**

#### **Assessment**

1. The photos will be assessed by a jury appointed by the Organizer. The Jury's decisions are final.
2. The photos will be assessed according to the following criteria:
  - a) substantive quality (artistic value of the photo, original approach, interesting or innovative idea, promotional potential);
  - b) respond to the given task
  - c) technical quality (quality of photos, following the technical requirements);

### **§ 4**

#### **Prizes**

1. For the best photos in every country (Poland, Belarus, Ukraine) the Contest Jury will award 3 non-financial prizes (9 prizes in total) – sets of the PBU Programme attractive sport/tourist equipment:
  - 1<sup>st</sup> prize: a total value of approx. 125 EUR (including smartwatch, hoodie, sport towel, speed badminton set, picnic blanket, reusable bottle and other promotional gadgets)
  - 2<sup>nd</sup> prize: a total value of approx. 85 EUR (including smartwatch, hoodie, sport towel, reusable bottle and other promotional gadgets)
  - 3<sup>rd</sup> prize: a total value of approx. 65 EUR (including a hoodie, power bank, sport towel, reusable bottle and other promotional gadgets)

The Organizer reserves the right not to award some additional prizes.

2. The results of the Contest will be announced on the Programme website: <https://www.pbu2020.eu/en/news/> and its FB fan page [www.facebook.com/PBU2020/](https://www.facebook.com/PBU2020/).
3. If in the Participant's country the regulations oblige her/him to pay an income tax or other derivatives because of receiving a prize, this obligation rests with the Participant.

**Final Provisions**

1. The Contest rules are available on the PBU Programme website
2. The Organizer reserves the right to use the submitted photos free of charge for the needs of the PBU Programme promotion.
3. The Organizer has the right to distribute and process the submitted photos as part of the Programme's information and promotion activities, including the author's personal data (surname, first name) in all media without territorial and time restrictions.
4. If the contest application violates the rights of third parties or generally applicable law, the participant is solely responsible.
5. In justified cases, the Organizer has the right to cancel, amend or extend the Contest.

7. The final interpretation of the Contest Rules is the responsibility of the Organizer.
