The key objective of the project is to strengthen the protection of the state border, to prevent and combat illegal migration, human trafficking and to fight against cross-border crime through the development of surveillance systems, which will improve the effectiveness of border checks. Within the project the Polish side plans to purchase the equipment for the technical surveillance and DMR radio communication as a part of the establishment of the European border surveillance system EUROSUR. The Belarusian side plans to purchase equipment and materials to set up a security system of Perimeter surveillance and to arrange for transport equipment and portable technical equipment for border surveillance. The common trainings courses will be organized.

The problem identified on the PL-BY border is cross-border crime associated with illegal migration, smuggling of cigarettes and stolen vehicles. Using the equipment of technical border surveillance will provide proper protection of border crossing points from evading control, increase the effectiveness of checks.

The Belarusian partner has already built a logistics centre on BY side which will significantly influence the capacity to receive heavy goods vehicles cleared in Kuźnica Białostocka border crossing.

Improved effectiveness of infrastructure and procedures by reorganizing the vehicle traffic in the border crossing-point is the aim of the project. The number of road lanes for passenger cars and heavy goods vehicles will be increased up to 8 lanes (4 in each direction: 2 lanes for lorries, 1 for passenger cars and busses, a greenbelt + a VIP lane) on Polish side of road border crossing in Kuznica Bialostocka.

It must be stressed that the initiative is also connected with the common position of Polish and Belarusian sides, including the border authorities of both sides, that was also presented during meetings of the Subcommittee of Border Crossings and Infrastructure of Polish-Belarusian Intergovernmental Coordination Committee on Cross-border Cooperation. The Belarusian partner has already undertaken actions aimed at remodeling the road system on their side. The restructuring of the road system in both border posts will improve the capacity of the border crossing and will speed up the control process of vehicles waiting in lines. This will streamline the border traffic, reducing the queues in sensitive periods of the year, not only in the border crossing platform, but also along the national road no. 19 before the border crossing.



Strengthening of cooperation between Lublin and Lutsk regions, increasing the efficiency of border checks by improving the competence and qualifications of Polish and Ukrainian border and customs services is the issue of vital necessity as mutual border traffic between the two countries is very intensive and they are facing challenges in the area of security and crisis management. The activities within the project foresee 2 editions of postgraduate studies in this field: free of charge training for 25 groups of specialists (10 ppl/group, 40h). Each course will include 8 different modules (5h/unit): the pursuit of results, emotional intelligence, emotional control, focus on action, coping with stress, teamwork, team management, organization of personal work. Biofeedback training will be conducted (6h/person) using specialized equipment aiming to raise the level of certain psychophysiological indicators.

Organization of 3 conferences and publication of 4 academic monographs will affect wider promotion of problematic aspects within matter under discussion. It is going to influence positively the cross-border agencies in PL and UA, universities as well as the society on both sides of the border. Project aim is to improve security at Belarusian-Polish border by installing weight metrical complexes at BCP"Domachevo" for weighing cargo vehicles, to improve quality of customs control, reduce time for border crossing. Lack of weight equipment does not allow to maintain border efficiency and security at proper level. Project implementation will improve conditions for border crossing through BCP "Domachevo", help reduce waiting time, determine the actual weight of the cargo being moved. Speed and quality of customs control procedures are expected to increase. Consequently, quality of performing customs control will improve.

Cargo carriers and persons crossing the border at BCP "Domachevo" as well as personnel of border, customs and other services at the border will benefit from the project. Project objectives and expected results will be achieved by cross-border approach to the project implementation, installation of weight metrical complexes at BCP "Domachevo", holding of experience exchange activities with the Polish partner, which will create the conditions necessary for operative and safe border crossing in both directions.

Project aim is a solution of cross-border problems in the sphere of illegal migration, contraband and human trafficking through Belarusian-Polish border. Prices growth for tobacco in EU countries influenced the increase of illegal tobacco products trafficking attempts from Belarus to neighboring EU countries. Recently there has been increase in illicit drug trafficking attempts. Natural persons and organized crime groups, usually of international character, carry out illegal goods trade.

Beneficiaries successfully use trained sniffer dogs. Further cooperation between dog services will lead to effective sniffer dogs' use, developing training methods and increasing safety of the Programme area inhabitants. Purchase of 11 special vehicles (5 for PL side and 6 for BY side) and experience exchange trainings will increase technical and personnel capacity of officials at Polish-Belarusian border. Vehicles will allow fast transportation of dog services to control places where there is an urgent need in them. Vehicles will also allow dog services to perform educational work aimed at fighting spread of drugs among the youth.

The project is aimed at the development of border management operations as well as improvement of Belarusian-Polish border security by modernization of local area network (LAN) at road border crossing points (BCPs) "Bruzgi" and "Berestovitsa". Belarusian and Polish sides strive to modernize the BCPs on both sides in parallel, as outdated equipment (average service life is more than 5 years) and low-speed communication channels used at "Bruzgi" and "Berestovitsa" BCPs cause a number of equipment failures. Modernization will ensure safety of customs data, security of customs systems data transmission and personal data of persons crossing the border.

Modernization of LAN (replacing obsolete and damaged optical and copper LAN cables; purchase and installation of LAN equipment, server and computer equipment, organizational equipment and specific software) will reduce number of breaks of customs control operations and reduce time of their execution. Cargo carriers and persons crossing the border at the BCPs "Bruzgi" and "Berestovitsa" as well as personnel of border, customs and other services at the border will benefit from project activities.
