3. OVERVIEW OF THE IMPLEMENTATION OF THE PROGRAMME

3.1 Executive summary


In the reporting period, the Programme entered into the advanced stage of implementation with all 10 LIPs and 64 regular projects from the 1st CfPs being implemented as well as 89 micro-projects within the 2nd and 3rd CfPs (12 of the approved projects resigned from implementation) contracted, out of which 48 have started implementation of their activities. 8 micro-projects from the 2nd CfPs have already completed their actions.

The total amount of projects contracted by the end of the reporting period makes 188 178 297,14 EUR (with 167 005 441,89 EUR of EU-funding). The Programme budget allocation (EU-funding) to contracted projects and payments in division to specific thematic objectives is presented below:

JTS team was involved in day-to-day implementation of the Programme, coordination of the projects implementation, contracting of micro-projects, communication and preparation of the new Programme edition.

In the reporting period, the Joint Programming Committee for the preparation of the Interreg Poland-Belarus-Ukraine Programme 2021-2027 continued its work via e-mail and on-line meetings communication.

Recalibration measures toward Belarus within PBU 2014-2020:

Following the Council Conclusions of 12 October 2020, the Programme adopted numerous measures in order to recalibrate Programme EU assistance to Belarus to ensure it benefits the population at large notably by directing it to the maximum possible extent away from central authorities and towards non-state, local and regional actors. All the measures were in line with DG REGIO guidance (letter of 9 June 2021) and included:

1. a systematic and careful screening of all operations in order to exclude any person or entity (including their shareholders) subject to EU restrictive measures, at any level. Whenever needed, the contractual instruments to protect the integrity of the EU budget must be used. This includes the application of the notional approach and the recovery of disbursed funds.

All PBU projects implemented within Polish-Belarusian partnership were monitored in terms of the participation of the central authorities of Belarus and their regional branches as beneficiaries. Monitoring included also contracts awarded as part of projects in terms of the participation of people and companies from sanctionsmap.eu. The JTS reviewed the list of companies with sanctions. The scope of their activities does not coincide with the activities of the beneficiaries of the Poland-Belarus-Ukraine program in the financed projects.

2. a case-by-case assessment of already contracted projects to identify and exclude risk of misuse;

All projects were reviewed and the list of high risk projects were established.

All high risk projects were inspected on site by the Brest Branch Office of the Joint Technical Secretariat and the Belarusian Control Contact Point. During the checks, particular emphasis was placed on checking the use of equipment purchased under the projects. The checks did not reveal any irregularities. The most frequent identified shortcomings include delays in the implementation of tasks and insufficient visualization (poorly visible labeling of EU funding).

Additional JTS support for Polish beneficiaries concerning the correct implementation of projects on the Belarusian side were provided.

The Polish Ministry of Foreign Affairs received a list of projects with the participation of Belarusian partners to submit it to the EU Delegation in Minsk in order to obtain confirmation by the central Belarusian authorities of the intention to fully implement the current PBU projects.

3. amending grant contracts whenever justified and in line with the legal provisions in order to re-orient the assistance away from central-level beneficiaries to activities benefitting the Belarus population, and with no risk of misuse;

All projects were reviewed to asses a possible termination of the contracts or necessity of changing of the scope of activities. This assessment were performed after obtaining the results of on-the-spot checks of high risk projects. In projects involving partners from Belarus the possibility of amending, extending the project implementation period and using project savings was limited to the necessary minimum.

4. the set-up of continuous monitoring systems for all projects involving Belarusian central authorities, in particular for Large Infrastructure Projects;

Regular monitoring of high risk projects and Large Infrastructure Projects is established within the Programme. This includes the Brief Narrative Reports (submitted for each 6 month period), Project Interim Report (financial and narrative), on the spot checks, and contact on a daily basis in order to obtain valid information on projects implementation (ad hoc reports for the MA and other Programme bodies).

11 high-risk projects were identified in which central institutions from Belarus or their branches participate. In accordance with the recommendations of the National Bank of Poland, when making payments, verification of the purpose for which the funds were allocated (including the economic purpose of the transaction, whether the payment is related to military activities, the delivery of which goods the transaction concerns).

5. the cancellation of all selected, but yet not-contracted projects when a risk of misuse exists;

The Programme did not decide to suspend the implementation of projects or terminate the contracts. Risky projects are subject to constant monitoring, and additional checks on the result of which we make the payment of funds dependent.

6. a reorientation of programme activities, as much as possible, towards actions in direct support of the people of Belarus.

Since no new calls for proposals were held in the reporting period the possibility to reorientation of Programme activities is limited.

All information and promotion activities of the Programe focused on maximizing public participation (events open or targeted at specific social groups, e.g. students, the elderly etc.). Contacts with the central authorities of Belarus were limited to the necessary participation in the meetings of the JMC and the programming group.

3.2 Progress achieved in implementing the Programme and its Priorities

Within the reporting period the following key performance indicators were achieved:





a) Contracting/implementation of projects

Regular projects:

- 64 were being implemented,
- 1 grant contract signed,
- 19 finished their implementation by 30 June 2021,
- 4 closed (final reports approved).

LIPs:

- 10 were being implemented,
- 1 finished its implementation by 30 June 2021,
- 1 closed (final report approved).

Micro-projects:

- 49 were being implemented,
- 89 grant contracts signed,
- 9 finished their implementation by 30 June 2021,
- 5 closed (none of the final reports approved by 30 June 2021),
- 24 micro-projects contracted in the reporting period.

JMC written decision on selection of projects for financing within 3rd CfP – 26 micro-projects have received EU funding, other 11 were placed on the reserve list. Eligibility check of all beneficiaries has been carried out. 24 micro-projects have been contracted within reporting period.

b) Reporting

- 107 brief narrative reports,
- 40 financial reports checked and approved.

Micro-projects:

- 30 brief narrative reports,
- 5 final reports received, none approved by 30 June 2021.

c) Trainings for beneficiaries

- 3 on-line trainings on implementation for regular projects/LIPs (PL, UA and BY beneficiaries);
- 1 training on implementation for regular projects/LIPs;
- 1 on-line training on procurements below 30.000 EUR for micro-projects (PL beneficiaries);
- 5 on-line tailor-made workshops on reporting and closing issues for micro-projects (PL, UA, BY beneficiaries who were finalizing their projects);
- 7 on-line trainings on implementation micro-projects (PL, BY, UA beneficiaries);
- Individual consultations for contracted micro-projects.

d) **Projects modification**

- 71 Addendums signed for regular projects/LIPs and 40 for micro-projects;
- 52 minor modifications introduced in regular projects/LIPs and 22 in micro-projects.

e) Other

- To strengthen the measures already taken by the PBU Programme to support its beneficiaries in fighting the COVID-19 outbreak, the Programme introduced the possibility to make use of the Programme savings and enable the Programme to cover up to 100% of the eligible costs for selected projects (12 healthcare projects);
- On-line materials, FAQ section, instructions for beneficiaries were published on the Programme website.

3.3 Problems and achievements reported by project applicants and beneficiaries

3.3.1 Summary of issues reported

The biggest problem that affected beneficiaries was COVID-19 pandemic and its restrictions which were especially visible in implementation of soft actions gathering larger number of participants. The requirement of social distancing, limitations regarding the public meetings and events and other introduced administrative anti-COVID measures significantly decreased the pace of projects implementation and resulted in numerous prolongations of projects' schedules.

Main issues reported by the beneficiaries were connected with COVID-19 pandemic:

- Administrative limitations regarding organisation of events and meetings,
- Temporarily closed borders and restrictions regarding traveling,
- Lack of workers due to illness and quarantines.

Some beneficiaries still complained about effects of the Ukrainian Administrative Reform and necessity of adaptation to new internal Belarusian regulations like changes in partnership composition or new project starting date.

Moreover, current situation in Belarus clearly affected PL-BY projects – e.g. lack of contact between partners, unexpected decisions of particular Belarusian partners concerning resignation from project implementation, problems with money flows – all these factors resulted in postponements in implementation of many projects and some cancellations of grant contracts implementation.

3.3.2 Success stories

Although it was a difficult time for beneficiaries of micro-projects, mainly due to the pandemic situation and political climate (lack of possibilities to organise people-to-people initiatives, limitations in participation in public events, difficulties in crossing of the borders etc.), only part of them decided to resign from project's implementation from that reason. Many of them postponed the initial project start date or extended duration of micro-projects but also tried to implement their activities. Some of them changed stationary events into on-line meetings, put more emphasis on virtual promotion (films, workshops, guides etc). They managed to overcome the obstacles and implement the activities, even if in many cases they had to be adjusted to the new conditions.





Definitely, projects consider it successful that they are able to implement their actions in the current situation, highlighting the flexibility of the Programme that helps implementation of activities during these days.

Selected success stories:

CBCpaths (PLBU.01.01.00-20-0794/19) – a joint tourist product of 10 communes is being created and promoted ("Bialystok Functional Area Pearls" route), a common calendar of cultural events of the region was published for the first time and the Beneficiaries will continue to publish it in the future, moreover, Belarusian events are promoted on the Polish Beneficiary's website and Polish events on the Belarusian partner's website. The Beneficiaries are proud of the common initiatives and satisfied with a very good cooperation.

MountainTaste (PLBU.01.01.00-UA-0802/19) – the cookbook was very much appreciated by the recipients; workshops on Boyko cuisine are continued after the project's end, even in September 2021, the festival "Master-Classes of Boyko cuisine" will be held with the co-financing of Skhidnytsia village council. Local housewives share recipes and owners of cafes and restaurants already have local dishes in their menus.

4_SEASONS (PLBU.01.02.00-UA-0813/19) – a competition for ideas of tourist routes for 4 seasons of the year has been organized in PL and UA and, as a result, 8 new tourist routes invented by inhabitants and local activists and further developed by the experts have been created on both sides of the border to promote the cross-border regions.

WoodenRoute (PLBU.01.01.00-18-0834/19) – a cycle of concerts and guided tours in the wooden churches promoted the route, modernization of the webpage on wooden architecture route together with creation of 4 VR, as well as its positioning, helps to attract visitors and tourists.

East_promotion (PLBU.01.01.00-06-0880/19) – among many activities implemented by eight project partners, "Multicultural Borderland" in Wojslawice together with concerts in the synagogue nearby has been considered a real festival of the three cultures: Polish, Ukrainian and Jewish and a symbol of friendship among the nations. The Beneficiaries have also designed and marked two bike routes which are a tangible result of the project.

SlowRivers (PLBU.01.02.00-18-0889/19) – the inventory and development of strategy for water tourism on San and Strwiaz rivers helped to rediscover the huge potential of this type of tourism. Promotional events, i.e. kayaking and rafting trips have shown great interest and need for such activities – the Beneficiaries could invite only one third of the persons willing to take part in each event.

GAMPOL (PLBU.01.02.00-06-0914/19) – three versions of the "Game of Polesie": LARP game, board game and online game are being prepared to promote the most valuable places of Polesie.

Traditions (PLBU.01.01.00-20-0825/19) – started during the summer and managed already to organize sculptural and pottery plain-airs gathering local artists.

MATSYK (PLBU.01.01.00-UA-0852/19) – international gastronomic conference in Lublin, Gastronomic festival in Rivne with a great coverage of the target audience in combination with the culinary guide/catalogue MATSYK has brought the popularity not only to the dish itself but the regional gastrotourism. As one of results is the Cooperation agreement between the city administrations for Rivne and Lublin in field of joint promotion of common culinary heritage has sealed the sustainability effect on the action.

ETHNOTOUR (PLBU.01.01.00-UA-0929/19) – folk craft clubs established for Polish and Ukrainian children in Perechyn and Lezajsk are serving the promotion of the common cultural features of Lemkos and Lasowiacy traditions on the borderland and have a substantial popularity and demand among young audience that is quite actual and crucial for keeping the pulse of local culture in conditions of the modern mass culture involvement.

Some of micro-projects from the 3rd CfPs have already started. One of them – *VetHeritage* (1055) has already organized a training on digitalization of archive data, necessary for further implementation of project activities, related to veterinary medicine.

In the reporting period all 10 LIPs were within their implementation phases. By the end of reporting period 1 project finished its implementation, submitted Final Project Report, were settled and closed. Next projects submitted their interim reports and received 2nd tranches of prefinancing.

The main problems identified in projects were connected with COVID-19 pandemic. The requirement of social distancing, limitations regarding the public meetings and events and other introduced administrative anti-COVID measures significantly decreased the pace of projects implementation.

Title of the project: Extension/rebuilding of the regional road No. 885 Przemysl - Hermanowice - State Border in km 3+642 - 10+257 Lead Beneficiary: Podkarpackie Regional Road Management

Budget: 7 500 000.00 EUR

ENI co-financing: 6 750 000.00 EUR (90%)

The objective of the LIP885 project is to support cross-border development processes in the borderland of Poland and Ukraine by improving transport accessibility and the condition of road infrastructure. This will be achieved through the modernization of almost 7 km of the regional road No. 885 on the state border, between Przemyśl and Hermanowice, which is the main activity of the LIP885 project. As a result, the project will allow for communication accessibility at the designed Polish-Ukrainian border crossing Malhowice-Nyzhankovychi.





The implementation of the project will increase the accessibility from the Podkarpackie Voivodeship into Western Ukraine and vice versa. The effect of the planned modernization will be the creation of a new road connection between the two countries, an alternative to the existing Przemyśl–Medyka–Lviv connection. It will reduce discrepancies in infrastructure and will result in the creation of a new investment area in the vicinity of the expanded road as well as an increase in international traffic mobility.

In the reporting period the contracts necessary for project implementation were concluded with STRABAG Spółka z o.o, Contract Engineer - KDI Sp. z o.o. Krosno., Project architects' supervision.

On 03/09/2019, the construction site was officially handed over to the Contractor of construction works. Since signing the Agreement, the STRABAG has been carrying out the works under the Contract in the full range. Contractor completed construction designs - executive designs, preparatory works, works on the M1 and M2 bridges are underway, pavements, bus bays and road construction are under construction. During the construction works, archaeological sites were discovered.

The first installment 2 362 500 Eur was paid on October 3, 2019.

The project aims at improving the security and mobility on the external border of the European Union through modernization of the rail border crossing in Siemianówka – i.e. Polish side of the border crossing point with Belarus, Siemianówka–Svislach. The modernization of this transition will entail, among others, the construction of the administrative building for the needs of passage service, a helicopter landing pad, an observation footbridge and assembly of devices – railroad scale, equipment for the control of cisterns and railway carriages, equipment for monitoring the tracks and the area of passage.

The objectives of actions foreseen in the project are to prevent and combat illegal migration and smuggling, fight organized crime as well as counteract and eliminate illegal trade of rare and endangered species. Project implementation will be beneficial to the Border Guard officers, Customs Service officers, employees from the Border Crossing Ser-vice Department, as well as entrepreneurs and local government authorities. In the long-term perspective, the positive effects of the project are expected to be noticeable also to citizens living in the region due to its social and economic development fostered by the project's results.

In the reporting period the tender procedures for conducting construction works has been finalized and contract for construction works has been concluded. The implementation of the project is realized without delays. A railway scale for weighing wagons was installed and launched. The decision of the Podlaskie Voivodeship Construction Supervision Inspector to use the railway was obtained. Furthermore, the permit of the Poviat Construction Supervision Inspector to use buildings 3 and 4 as well as helicopter landing area was obtained. On 30/06/2020 the construction site was officially handed over to the Contractor of construction works.

Title of the project: Improvement of accessibility of the border region via upgrading of the regional road No. 698 including renovation of the bridge on the Toczna River in Losice Lead Beneficiary: Mazowieckie Voivodeship (Województwo Mazowieckie) Budget: 5 100 000,00 EUR ENI co-financing: 4 590 000,00 EUR (90%)

The scope of the DW698 project includes reconstruction of the provincial road No.698, construction of traffic lights and renovation of the bridge on the Toczna River in Łosice, as well as the renovation of the provincial road No.698 between Stok Lacki and Mordy. The project shall also include completion of road construction, electricity, telecom, rainwater and sanitary installations and bridge construction works.

The project is expected to boost the transport accessibility of the region which in turn shall lead to strengthening of cross-border economic, touristic and social links. In the aftermath of the project implementation, the conditions for entrepreneurship development in the area and the life quality of its inhabitants will be improved. As a result of the improved road system, starting new relations, including business relationships, will be substantially facilitated. The upgrade of technical parameters of the roads provides a chance to prompt local inhabitants to increase their social and economic engagement.





In the reporting period the tender procedures for conducting construction works has been finalized and contract for construction works has been concluded. The implementation of the project is realized without delays. The construction work is well under way. The road in the town of Mordy is being renovated, including replacement of curbs and reconstruction of the cobblestone pavements and creation of rainwater drainage system (the latter is almost complete). A section of the road from the bridge over the Liwiec river in Wyczółki to the city center has been renovated (works completed, excluding the payment of stripes). The construction works on the bridge over the Toczna river in Losice are almost finished. The works on the town streets (renovation of the crossing of Narutowicza and 11 Listopada streets, equipping the intersection with traffic lights, changing the surface along Bialska Street, including the parking places) are in process.

Title of the project: Extension of the voivodeship road No 812 on the section Korolowka - Wlodawa Lead Beneficiary: Lubelskie Voivodeship (Województwo Lubelskie) Budget: 6 653 700,00 EUR ENI co-financing: 5 636 349,27 EUR (84,71%)

The strategic objective of the project is to improve the quality of the transport infrastructure and accessibility to the region. This is planned to be achieved through the reconstruction of almost 5 km of the voivodeship road No.812, on the Korolówka–Włodawa section.

Voivodeship road No.812 is one of the roads with the highest traffic intensity in the Lubelskie Voivodeship, with average daily traffic in the Włodawa area reaching 5 727 vehicles (2015 data). This road is also characterized by a high number of accidents (which in 2011 accounted for 6.7% of all accidents taking place on Lubelskie regional roads). The RDW812 project implementation will contribute to improving the overall road-traffic conditions, thus reducing the number of road accidents. The investment shall shorten the travel time between the planned road border crossing of Zbereże–Adamczuki and the TEN-T network (national roadNo.17) by about 5 minutes. The modernized infrastructure will provide faster, more comfortable access to the region and will strengthen its investment and tourism potential.

Construction works related to the extension of the voivodeship road No 812 have been fully completed and the newly reconstructed road of approximately 5 km have been commissioned. The road was equipped with pedestrian sidewalks and bike paths in the built-up area and with bike paths with permitted pedestrian traffic outside built-up area. The modern vehicle with a special equipment for winter and summer road maintenance was purchased.

Due to the spread of Covid-19 the international Conference planned to be conducted during the summer time had to be cancelled.

The partnership tied up during the joint implementation of the project served as a basis for signing an Cooperation Agreement between Regional Road Administration in Lublin (a body responsible for the project implementation) and Volyn Regional State Administration.

All project results and achievements have been widely promoted via radio spots, press advertorials and articles, project's website and info printed in the media web portals as well as via the video spot distributed among main project stakeholders and a promotional film published on Youtube platform.

Title of the project: Polish-Belarusian Cross-Border Safety. Strengthen of fire and rescue services potential Lead Beneficiary: Brest Regional Department of the Ministry of Emergency Situations of the Republic of Belarus Budget: 4 716 670,00 (increased by the Beneficiary) ENI co-financing: 4 056 003.00 (85,99 %)

The project supports the creation of an efficient joint system of monitoring and prompt responses to various emergency situations in the cross-border territories of Belarus and Poland. As part of the project, the fire station in Kamianets will be reconstructed and two training centers for the rescuers in Brest and Hrodna will be created and equipped. Special equipment for fire stations in Brest and Kamianets will be also purchased. Moreover, the partners will organize a cycle of thematic trainings for firefighters-rescuers and will raise awareness among the population of the regions.

Achievement of the project results will improve the populations' quality of life through the reinforcement of people's property and ecological safety in the cross-border territories of the Polish-Belarusian borderland. The project will create a more attractive region for inhabitants, tourists and investors.

The project is on a final stage of implementation.

Reconstruction of the fire station in Kamianets was completed earlier, technological equipment has been installed in it. Creation of a Safety Centre on the basis of the fire station (additionally introduced activity) is completed. Reconstruction of the Training and Educational Centre in Brest is completed.





Implementation of purchases for the training center in Hrodna are on the final stage. Due to the Covid-19 the joint training exercises of the rescuers of Belarus and Poland have not been held.

As a part of the awareness-raising campaign, various activities with the target group were held: two open days on the basis of the fire units of the Brest and one seminar. Educational brochure "Main Emergency Situations, Actions for Liquidation" was published.

Beneficiary 1 has increased own contribution, thus the percentage of the ENI co-financing has changed from 90,00% to 85,99%. The project was twice prolonged. Current project implementation period end – 31/08/2021.

Title of the project: Improvement of border region road infrastructure ensuring sustainable access to the border region (modernization and construction of road P-16)

Lead Beneficiary: Public Unitary Enterprise of Motorway Roads "Brestautodor" Budget: 5 160 000.00 EUR ENI co-financing: 4 644 000.00 (90%)

The project aims to make the cross-border region more accessible by improving public transport links through modernization (3,85 km) and construction (9,46 km) of road P-16. After reconstruction, the road P-16 will be upgraded from IV category to III category (with a width of 7 m). Limitation of speed will change from 40 to 90 km/h and as a result, throughput will increase while ensuring less time for transportation.

Due to implementation of the project road, P-16 will be used for the international movement of buses and trucks directly to the border crossing, without the necessity to pass through populated areas. Implementation of the project will improve the accessibility of the regions, development of communication networks and systems, including development of transport services and infrastructure. Sustainable access to the border region and taking care of the environment make the regions more attractive to residents, tourists and investors.

The project is on a final stage of implementation. Modernization and construction works on the road P-16 ("Highway P-16 Ciuchiničy – Vysokaje – border of the Republic of Poland (Piasčatka), km 20,000 – km 41,000") were completed in September 2020. The act of commissioning the site was approved on October 13, 2020. Two memorial boards with program logos and EU symbols were installed at the entrance and at the exit of construction site.

Soft activities were conducted in October and November 2020 (seminar "Exchange of experience in the road section", conference "Innovations in the road sector", conference "Impact of the project on the socio-economic indicators of the region").

Beneficiary has used generated savings for the purchase of additional road equipment (tractor, mower, loader, brush), that will be used for the maintenance of the road P-16, preserving the achieved technical and economic indicators for a long period and will increase the safety of road users.

The project ends in July 2021.

Title of the project: Establishment of the system of dynamic response to information of crimes and other events in Lviv Lead Beneficiary: Lviv Regional Board of Administration of the National Police Budget: 6 000 000.00 EUR ENI co-financing: 5 400 000.00 EUR (90%)

The objective of the project is to tackle the problem of long waiting time for help requested for crimes and other incidents in Lviv. The average waiting time is 20 minutes but can even reach 40 minutes. Everybody including residents and visitors, need to feel safe, protected and be able to get help in a timely manner. The project will help regional and local authorities to respond to the common challenges in the field of safety and security.

According to a sociological survey conducted in Lviv, 76% of inhabitants feel safe in the city during the day and only 40% at night. The project implementation aims to increase these numbers to 85% during the day and 60% at night. The waiting time for help will decrease from 15 to 5 minutes. To achieve this goal the new administrative building will be completed and equipped with a system that gathers data received from CCTV city cameras, six police stations located in Lviv will be reconstructed, and a new administrative building will gain an integrated multiservice telecommunication system. Moreover, the emergency communication subsystem, based on operative information and monitoring response of crimes, will improve, as well as a data transmission net-work with CCTV cameras will be created. The main objective is to coordinate the cooperation of emergency services to provide security and required help to the citizens and visitors of Lviv.





Through the achievement of the planned actions, the project will affect development of the region, significantly reduce the number of crimes committed in public places and create conditions for prevention thereof. This will increase tourist flow and allow Lviv citizens and visitors to feel safe and receive timely and accurate help in situations of threat.

Initially the project implementation was delayed, due to the long process of signing of Memorandum between the National Police of Ukraine, Lviv Oblast Council and Lviv Oblast State Administration to ensure own co-financing within the project, and also getting necessary approvals, further complicated with COVID-19 situation. To overcome negative epidemic consequences, the project implementation period was extended until January 22, 2022. Also, the issue was brought to the highest level of national authorities on the meeting on 9 March 2021, with the participation of Prime-Minister of Ukraine. As a result, the monthly project reporting was established at the highest national level and the project is currently in the active implementation phase. Lead Beneficiary has completed all preparatory activities, related to the infrastructure, such as getting necessary permissions, purchasing project design and architectural supervision services for all buildings. The construction of the new administrative building and re-construction works for 6 police stations is ongoing. Also, the following equipment for the new space has been purchased: 100 tablets, 80 laptops and 25 printers. The procurement process ongoing for diesel generator, 580 body-worn cameras, 170 automated workplaces with analytic equipment, equipped vehicle for operative sudden action, crime scene car, and mobile command dispatching station vehicle. The development of communication network, aimed at integrating the video surveillance system into a single unit and allow police officers to access video surveillance networks for the needs of operative management of special operations, search of criminals on hot tracks, implementation of preventive functions, is 85% completed. The remaining equipment – CCTV cameras, analytic traffic control complexes and server equipment will be procured after receipt of the 2nd tranche.

Title of the project: Reducing of the risk of TB epidemic in the border areas of Ukraine and Poland through the construction of tuberculous hospital for 100 beds in Zakarpattya Oblast and introduction of innovative methods of tuberculous monitoring, prevention and treatment Lead Beneficiary: Health Department of the Regional State Administration of Transcarpathian Region Budget: 6 400 000.00 EUR ENI co-financing: 5 760 000.00 (90%)

The overall objective of the project is to reduce the number of TB incidences in the Programme area which will be achieved primarily by building the TB hospital in Nyzhnya Apsha village (Zakarpattya, UA) equipped with modern medical equipment and innovative approaches to TB detection, prevention and treatment. Improvement of medical equipment in the Frederic Chopin Regional Clinical Hospital No.1 in Rzeszów is also foreseen in the project. As a result of the implementation of cost-effective treatment and raising the quality of medical services in the field of TB the project will increase the effectiveness of TB detection up to 5%, reduce the long-term incidence by 1.5 times and improve the epidemic situation of tuberculosis in the border areas. These actions will affect the final beneficiaries of the project – 75 000 citizens covered by improved health services. Closer cross-border cooperation and exchanging experience between medical institutions of Ukraine and Poland shall lead to the achievement of the project's goals.

In the reporting period the Lead beneficiary has completed preparatory activities for the infrastructure and is carrying construction of tuberculosis hospital for 100 beds in Nyzhnia Apsha. As reported, the approximately ¼ of the works has been finished. At the same time, works on artesian well and heating networks on individual buildings are nearly finished. The readiness of utility and disinfection buildings and external water supply networks is over 50%. Beneficiary 1 (Frederic Chopin Regional Clinical Hospital No. 1 in Rzeszow) purchased video-bronchoscope and bronchoscope. The Beneficiary 2 (Communal non-profit enterprise "Regional clinical phthisiopulmonology treatment and diagnostic center" of the Transcarpathian regional council) purchased 2 mobile X-ray diagnostic rooms, 4 oxygen generators and a minibus. The delivery of 2 specialized medical vehicles is expected in fall of 2021.

Work is underway to develop a pilot model for tuberculosis detection based on an assessment of the baseline status of tuberculosis detection in at-risk groups, and also guidelines for "Organization of outpatient infusion therapy rooms". The consequences of COVID-19 epidemic were particularly unfavorable for the project, since the Beneficiaries 2 and 3 were overwhelmed as COVID-hospitals, and to overcome epidemic negative consequences, the project implementation period was extended until December 31, 2021.

Title of the project: Construction of the relocatable X-ray scanning control system of vehicles at the border checkpoint Berestovitsa Lead Beneficiary: Grodno Regional Custom House Budget: 4 500 000.00 EUR ENI co-financing: 4 050 000.00 (90%)





The challenge is to improve safety and increase transit location that will lead to further improvement of external economic relations and increase the competitiveness of the region. The project shall contribute to the solution of the above problem, by implementing the new technology of "non-intrusive" (without the need to open vehicles or unload) inspection at the border crossing-point "Berestovitsa". The project involves the contruction of the X-ray scanning control system, including scanning equipment, a shed building for it and a building for personnel, utility systems, passageways, parking for vehicles, training for experts to work with the scanning equipment and organization of speeded up inspection of vehicles. To gain on the cross-border project implementation, project partners plan the exchange of experiences, particularly on the application of the X ray data. Thus carriers and people crossing the border at the check-point "Berestovitsa", as well as officers of the border guard, customs and other services will benefit from the project implementation. Using the technology of non-intrusive customs inspection will create necessary conditions for prompt and safe border crossing in both directions.

After the significant delay the project entered the active phase of implementation. Construction works on the object of a stationary X-ray scanning complex are in process. The interior decoration works in the administrative and dispatch building has been completed, plumbing equipment has been installed. Drainage devices, ventilation and fire-protection systems in the hangar building for X-ray scanning complex were installed. Currently, works are being completed on the installation of concrete pavement for driveways platforms, sealing of expansion joints and installation of drainage devises. Equipment for the complex has been purchased and delivered.

Title of the project: Improvement of the environment within the Shatsk National Natural Park by building sewer systems in rural settlements around Lake Svityaz

Lead Beneficiary: Shatsk District State Administration of Volyn Region Budget: 6 450 000.00 EUR ENI co-financing: 5 805 000.00 EUR (90%)

The overall objective of the project is to prevent the spread of human and animal diseases in Volyn Oblast (Ukraine) and Lubelskie Voivodeship (Poland). The cross-border approach is aimed at combining efforts of beneficiaries to improve the sanitary and epidemiological situation of the biosphere reserve "Western Polissia". The project will do so by building the sewage system in rural settlements around Lake Svityaz. Thanks to the development of sewer networks and sewage treatment plants in the settlements flow of polluted sewage to subsoil waters will decrease by 80%, which will reduce the pollution of Shatsk National Natural Park lakes and basins of the Western Bug and Prypiat.

In the reporting period the project was implemented according to the schedule. The Lead Beneficiary continued construction of the sewer networks and sewage treatment plants. In particular, sewer network and system of sewage treatment in Gajivka and Melnyky and Svityaz village were installed and connected to relevant sewage pumping stations. Electrical installation works, street lighting and installation of air duct were performed in Pulmo. The readiness of infrastructure is over 95%. Water and sewage damage restoration truck was purchased. The training and visit of Ukrainian staff to Polish plants was postponed to due to COVID. Also, it should be noted, that during the reporting period, the LB - Shatsk District State Administration of Volyn Region, was subject to liquidation due to the administrative reform in Ukraine, and regional state authority took over to coordinate the process of LP legal succession to Kovel district State administration. The transformation process lasted few months in spring 2021 and the project implementation slowed down during this period, as the project accounts were closed and staff released, therefore the regional state authority stepped in to coordinate the process. The necessary documents regarding LP legal succession and also project extension until December 31, 2021, were submitted to and approved by the Joint Monitoring Committee in the end of June 2021.

> Main activities of the MA undertaken in the reporting period:

- preparation (with the assistance of the JTS-IB) Programme documents submitted for the approval of the JMC;
- overall co-ordination of the evaluation process of the project proposals submitted within the 3rd call for proposals and chairing the Project Selection Committee;
- handling complaints submitted by the applicants of the 3rd call for proposals;
- participation in events/seminars/workshops/meetings on the Programme implementation organized by TESIM, INTERACT, European Commission;
- participation in Programme events (JPC meeting, seminars and trainings for the applicants/beneficiaries);
- conducting fraud risk assessment for the Programme in line with the assumptions of the European Structural and Investment Funds Guidance for Member States and Programme Authorities "Fraud Risk Assessment and Effective and Proportionate Anti-Fraud Measures";
- contracting of the projects, signing addendums to the grant contracts;
- developing solutions for beneficiaries of PBU1, PBU2, PBU3 and the LIPs in relation to COVID-19 epidemic threat and political situation in Belarus;
- projects reports verification and paying out of the advance payments to the project beneficiaries;
- updating of the MA Procedure Manual;
- modification of the JTS Procedures Manual and approval of the amended version of the document;
- conducting a systemic control of the JTS's and Polish CCP's performance and realization of entrusted tasks;





- works regarding preparation of PBU programme 2021-2027 preparation of documents and conducting JPC/NAs consultations regarding i.a. rules for LIPs and microprojects, division of allocation, initial assumptions on financing & reporting system, initial assumptions on audit system;
- drafting solutions/scenarios on the 2021-2027 Programme development in relation to political situation in Belarus and situation on Polish-Belarusian border.

> Main activities of the JTS and Branch offices

With regard to the Programme 2014-2020 implementation the JTS was responsible for day-to-day implementation of the Programme and all standard activities related to that:

- contacts with the Programme institutions, applicants and beneficiaries;
- overlooking grant contracts' and service contracts' implementation;
- assisting beneficiaries of PBU1, PBU2, PBU3 and the LIPs in implementation and communication of their activities;
- the Programme communication (full list of communication and promotional activities can be found in p. 4.4.1).

In that time JTS was and BOs were additionally concentrated on:

- contracting of PBU3 projects (micro-projects from 3rd CfPs);
- organization of various trainings for all beneficiaries in all three countries (full list of communication and promotional activities can be found in p. 4.4.1);
- participation in numerous events summarizing projects implementation;
- assisting beneficiaries of PBU1, PBU2 and the LIPs in relation to COVID-19 epidemic limitations;
- conducting on-the-spot verifications in the projects.

In the reported period, employees of the JTS assisted beneficiaries in the implementation of projects and events, communication activities and provided numerous individual consultations. Since the COVID-19 outbreak, the JTS additionally supports project beneficiaries in relation to difficulties caused by the pandemic. Numerous activities were introduced to diminish the effects of abrupt changes and minimize negative impact on the implementation of the Programme and projects.

With regard to the 3rd CfPs the JTS continued the preparation of grant contracts providing numerous individual consultations to the beneficiaries of the selected projects.

The JTS organized trainings on implementation, procurements as well as communication activities in Poland, Belarus and Ukraine. Necessary materials on project implementation were prepared, the FAQ section on the Programme website was updated.

The JTS and BOs employees took active part (presentations, panels, information stands etc) in several events organised by projects as well as national (Polish, Belarusian or Ukrainian) organizations, in some cases with co-organization and financing from the Programme TA (full list of these activities can be found in p. 4.4.1).

The JTS and the BOs, also in cooperation with the CCPs carried out first on-the-spot verifications in the projects. 32 on-the-spot verifications were conducted in the reporting period. Not all verifications planned in the Annual plan of controls were conducted, mainly due to the restrictions of COVID-19 situations. All the due controls will be finalised in the next reporting period. The JTS/BOs verified implementation of activities planned in the projects, output indicators, compliance of responsibilities on information and promotion and respecting equal treatment rules. The progress of activities declared in the reporting period was verified by the JTS/BOs if it is in line with the Grant Contract. As a result of the afore-mentioned verifications no irregularities were identified.

The JTS employees took part practically in all events organised in that time by TESIM and INTERACT that had any relations with the CBC ENI programme implementation and preparation of the NEXT Interreg programme.

In addition, several working meetings of the JTS staff with the BOs staff were organized regarding the Programme and projects related issues.

Besides, the JTS employees as usual took part in various trainings improving their professional qualifications as well as foreign languages skills.





The BOs in Poland, Belarus and Ukraine continued performing their tasks in the reporting period under the service contracts signed between them and MA. Main activities carried out by BOs, except for providing consultations regarding participation in the Programme and assistance to the JTS as well as projects in daily implementation, included:

- assistance to the JTS in organization of most of the Programme events listed in the point 4.4.1;
- assistance to the JTS in translation, proof-reading of documents, drafting of news for Programme web-site;
- preparation of the projects publications, Crossborderer, news on the Prorgamme website as well as organizing FB fanpage.

Relating the preparation of the Interreg PBU 2021-2027 Programme, following activities were carried out:

- Preparation of documents and materials for the JPC decisions;
- 2 meetings of the JPC PBU 2021-2027 held on-line;
 - 1st 10.12.2020 related LIPs preparation, Financing & reporting system, control system, IT system 2021-2027. The EC representative participated in the meeting
 - 2nd 10-12.02.2021 presentations of each of the direct award LIPs proposals by their partners and JPC discussion over each of them, recommendations to be included in the final project summaries preparation.
- Co-organization of MA / JTS / NA meetings;
- Cooperation with LIPs partners on their project summaries preparation;
- Participation in numerous workshops organized by European Commission, Interact, Tesim;
- Public consultations of the strategic part of the Programme document;
- Modification of the Programme document to include EC recommendations in reference to Belarus (cancellation of Priority Borders);
- Work over the SEA Report and its public consultations;
- Work over many technical aspects necessary for the new Programme such as the grant contract form, e-application system, eligibility of costs, use of SCO, etc.

Main activities of the CCPs and NAs

The Belarusian and Ukrainian CCPs have maintained the list of auditors entitled to verify the project expenditures incurred by, respectively, Belarusian and Ukrainian beneficiaries. Some modifications were introduced to the list.

Polish CCP continued to authorise Polish auditors entitled to verify the project expenditures incurred by Polish beneficiaries.

The Guidelines on Expenditure Verifications were updated to include necessary issues.

Generally, no major problems related to the current Programme management were identified. However, political situation in Belarus was negatively influencing the pace of the new Programme preparation.

The NAs of each participating country were in close contact and generally cooperated on the Programme implementation issues.

The CCPs carried out first on-the-spot verifications in the projects. The CCPs verify accounts, expenditures and Auditor's Certificate and Checklist for project control. As a result of the afore-mentioned verifications no irregularities were identified

The MA conducted another fraud risk analysis for the Programme with participation of the Polish NA (responsible for coordinating the programme management and control system), the JTS and Polish CCP. The analysis was carried out in line with the assumptions of the European Structural and Investment Funds Guidance for Member States and Programme Authorities "Fraud Risk Assessment and Effective and Proportionate Anti-Fraud Measures". The analysis is carried out on annual basis.

> Main activities of the AA

The Audit Authority carried out audit of operations and the system audit at the level of Managing Authority and Joint Technical Secretariat, between December 2020 and January 2021. Results were presented in the Annual Audit Report.

4.2. Management of the calls for proposals

Within the 1st CfPs during the reporting period due to the termination of 2 contract within previous reporting period and identified savings within the implementation of other projects the JMC took a decision to contract the project from reserve list:





- PLBU03.01.00-06-0217/17-00 The Borderland of Equal Treatment / Step by Step Association for Help to Disabled Children in Zamość (LB). Grant Contract were concluded on 14.07.2020.

Additionally as a response for COVID-19 crisis the JMC approved allocation of additional 3 MEUR for the healthcare cross-border cooperation projects to support them in fighting the pandemic outbreak. There are 12 projects (7 PL-BY, 4 PL-UA, 1 PL-BY-UA) involved including hospitals and social care centres, identified to purchase additional equipment or introduce new activities to better response to the crisis (while still implementing regular project activities).

Out of 3 MEUR, the projects have purchased among others:

- respirators,
- professional R- series defibrillator (support of the work of heart and lung function),
- modular intensive care units with ventilation module,
- video bronchoscope,
- oxygen humidifiers,
- ECG devices,
- resuscitator AMBU,
- cardio monitors,
- laryngoscope sets,
- pulse oximeters,
- sterilizers,
- mobile bactericidal irradiators,
- hospital beds and anti-bedsore mattress,
- diagnostic tests,
- as well as disinfectants and personal protection and other equipment and accessories needed to improve the functioning of medical facilities in the pandemic situation.

During the reporting period the process of signing of addenda increasing of value of the above medical projects were in progress.

To strengthen the above measures already taken by the PBU Programme to support its beneficiaries in fighting the COVID-19 outbreak, the Programme introduced the possibility to make use of the probable Programme savings and enable the Programme to cover up to 100% of the eligible costs for selected projects (12 healthcare projects). Within the reporting period no addendums in the matter were signed.

Within 2nd CfPs, out of 74 micro-projects selected, finally 65 projects decided to sign the grant contracts and 45 started their implementation. 9 projects resigned from funding.

3 micro-projects from the 3rd CfPs already started their activities (out of 24 contracted within reporting period). 3 micro-projects out of 37 (from the main and reserve lists) notified their official resignation. COVID19 pandemic and political situation in Belarus are the major reasons for resignations.



Map B: Organisations involved in grant contracts within 1st CfPs










Map A: Organisations involved in projects proposals submitted for funding within 2nd CfP



















Map A: Organisations involved in projects proposals submitted for funding within the 3rd CfP

4.3 Monitoring and evaluation (max 2 page)

As a general rule, monitoring system for the Programme is based on the information received from the beneficiaries, who are obliged by the grant contract to submit narrative and financial reports to the JTS. The system is based on narrative and financial reports submitted together with payment requests as well as start-up reports and six-months brief narrative reports (in case of regular projects) and brief reports covering half of project implementation period in case of micro-projects, submitted independently from the payment requests. Data received from beneficiaries is compiled at the Programme level in order to prepare annual Programme implementation report and other monitoring information. Additionally, the JTS is authorized to conduct on-the-spot checks and monitoring visits during projects implementation. These activities are conducted in accordance with the yearly plan of checks and ad hoc, if necessary.

During the reporting period the JTS received 107 brief narrative reports from regular projects and LIPs covering the periods of six months of projects implementation and 30 brief reports covering half of micro-project implementation period. The reports indicated proper project realisation in majority of projects, however minor delays in part of projects connected with their launching phase and COVID-19 pandemic were also observed.

During the reporting period 32 financial interim reports from regular projects and LIPs were submitted, verified and approved. In result the beneficiaries received 2nd tranches of pre-financing.





Additionally 5 final financial reports were submitted (4 regular projects, 1 LIP), checked and approved. Therefore the following projects shall be considered as closed:

- 3. PLBU.04.01.00-20-0572/17

5 final reports have been submitted by micro-projects, but due to the fact that none of them has been settled, no on-the-spot checks were conducted. Beneficiaries received 16 prefinancing payments worth 741.288,34 EUR.

Due to the pandemic the process of on the spot verifications were partially delivered. Within the reporting period 32 project beneficiaries/auditors (14 BY, 13 PL, 5 UA) were checked by the respective programme bodies (JTS, Branch Offices, Control Contact Points). No irregularities were detected within these checks. At the same time part of the on the spot checks which were not performed due to COVID pandemic by June 2021, were postponed to the next reporting period.²

Data on signed contracts are included in SL2014 (Polish national IT system for programmes/projects management) for monitoring purposes and provided to KEEP database.

As a result of all monitoring activities, including verification of payment claims, on-the-spot verifications, monitoring visits no irregularities above 10 000 EUR were identified. Irregularities below the afore-mentioned threshold were identified as a result of payment claim verifications and are reported in this annual report (financial part).

In the reporting period the Managing Authority finalised Mid-term evaluation of the programme. The objective of the evaluation study was to conduct a mid-term assessment of the degree to which specific objectives set for each priority axis of the Programme were achieved and to estimate the material and financial progress of the Programme. The study was aimed at the identification of factors influencing the scope of implementation of specific objectives set for individual priority axes. The study included the analysis of the degree to which horizontal policies (equality between men and women, equal opportunities and non-discrimination, and the principles of sustainable development) were implemented, and the assessment of information and promotion activities. Conclusions constituting the result of conducted study should be considered positive, however, most of them require confirmation over a longer period of time. The analysis of existing data and the results of qualitative and quantitative research indicated that the measures undertaken under the Programme were effective.

The Programme should be considered effective according to the evaluator's assessment. The strengths of the Programme include: its good organization and provided support; completeness and accessibility of the Programme documentation, leading to the efficient and effective implementation of all stages of the Programme starting from the call for proposals, evaluation of project applications and the assistance in finding an appropriate project partner, to enabling the implementation of projects and supervising them. However, the most significant strength of the Programme is the establishment of partnerships between Poland, Belarus and Ukraine, the implementation of joint activities aimed at improving the situation in the border area, and successful cross-border cooperation. The success of the Programme is also evidenced by the fact that it was met with considerable interest from applicants. Its weaknesses mainly consisted of the insufficient budget compared to the scope of interest in the possibility of receiving support. Most of identified difficulties shall be considered external in relation to the Programme, an example of which is the coronavirus pandemic and corelated limitations, or formal and legal barriers in partner countries. Another problem regarded the necessity to physically cross the Polish-Ukrainian and Polish-Belarusian borders, which often would be proven time-consuming and burdensome. However, these difficulties were mostly overcome, with the (often long-term) partnership cooperation minimizing the degree of their impact on the implementation of projects.
