

### Consent to the processing of personal data (children)

In accordance with Art.13, Art. 6 (1)(a) and Art. 9 (2) (a, h) of the General Data Protection Regulation of 27th April 2016 (EU Journal of Laws L 119 of 4th May 2016), in the name of **my son/daughter/mentee<sup>1</sup> (name and surname)** ....., I agree to the processing of his/her personal data in the following: name and surname, country, city, passport number, birth date, personal identity number, signature, voice and image, special dietary requirements and disability-related needs, by the Administrator - the Marshal of the Podkarpackie Voivodeship with offices at: 35-010 Rzeszów, Ciepłińskiego Av., 4 - in order to participate in the Youth Education Campaign within European Cooperation Day (EC Day) 2022 and the documentation of the Programme in accordance with its principles. Consent to the use of the image and voice includes the use, recording and reproduction of photos/films made during the EC Day 2022 through any medium, for purposes related to the promotion of the Programme, in accordance with applicable law, including publication in newspapers, periodicals, occasional magazines, folders, electronic publications, websites, exhibitions, contests etc. I agree that the results of his/her tasks (movies, pictures, texts etc.) performed within the EC Day 2022 may be used in the same way. At the same time, I will waive the rights related to the control and approval of each time use of above mentioned photographs or films containing his/her image/voice. In addition, I declare that I have been informed that at any time I have the right to withdraw my consent to the processing of his/her personal data. Withdrawal of consent will not affect the lawfulness of the processing that was made on the basis of consent before its withdrawal.<sup>2</sup>

### Information clause

In accordance with Art.13 of the General Data Protection Regulation of 27<sup>th</sup> April 2016 (EU Journal of Laws L 119 of 4<sup>th</sup> May 2016), we inform you of the following:

1. The Administrator of their personal data is the Marshal of the Podkarpackie Voivodeship with offices at: 35-010 Rzeszów, Ciepłińskiego Av., 4. Their personal data will be used for the purposes of organizing the Youth Education Campaign within European Cooperation Day (EC Day) 2022 as well as reporting activities of the Programme in accordance with Art.6 (1)(a) and Art. 9 (2) (a, h) of the General Data Protection Regulation of 27th April 2016.
3. The recipients of their personal data will be exclusively entities legally entitled to obtain and process personal data in compliance with the law: the Marshal Office of the Podkarpackie Voivodeship, the European Commission, the Joint Technical Secretariat and Rzeszów Branch Office of the Cross-border Cooperation Programme Poland-Belarus-Ukraine, the Contractor of the event and its subcontractors.
4. Their personal data will be held for five years from the date of payment of the final balance within the Cross-border Cooperation Programme Poland-Belarus-Ukraine 2014-2020.
5. Their personal data will not be used for profiling.
6. You have full legal rights to demand access from the Administrator to their personal data, to correct, delete, limit the processing, the right to object to the processing as well as to withdraw consent at any time, in accordance with the actual law.
7. You have the full legal right to launch a complaint to the President of the Office of Personal Data Protection.
8. Providing their personal data is optional, but refusing to provide the necessary data will not allow for the realization of legal proceedings of the Administrator and to perform task necessary for organizing their participation in the Youth Education Campaign within European Cooperation Day (EC Day) 2022.
